Minutes of the 10/26/2009 WCOA Football Membership Meeting at Jefferson at 7:00 PM.

Football board meeting called to order at 7:00 pm.

Ben Heugal (WCOA VP of Football):

Election business:

Each of the 3 candidates for VP of Football was given 3 minutes to address the membership.

Claude Burg, Ben Heugel and Jerome Ford.

Each of the candidates running for the 2 sports committee members positions up for re-election was given 3 minutes to address the membership.

Curtis Jackson, Greg Kaiser, Dave Stromquist and Steve Clouse Jr.

Election results were announced at the end of the meeting:

Claude Burg is our new VP of Football and **Steve Clouse Jr. & Dr. Kaiser** were both re-elected.

Steve Clouse Jr. (WCOA Board Member):

Steve explained what they are looking for on the game films.

Problem areas are: penalty reports without numbers or incomplete, missed calls, incorrect penalty enforcement, improper mechanics or positioning, poor signals, poor dead ball spots and no calls.

Harold Greenfield (WCOA Board Member):

Harold announced that all meeting minutes are on the web site available for viewing.

Also, the 2009 attendance & participation documents will be posted on the web site this week.

Doctor Greg Kaiser (WCOA Football Training Director):

Dr. Kaiser showed a presentation of 7 man mechanics to be used for 2009 play-offs.

There were some mechanics changes from last year. Which were explained during the presentation.

The official ball of all play-offs is the Spalding ball.

Ken Calhoun (Varsity Football Booking Commissioner):

Ken stressed the importance of keeping you availability as current as possible.

Ken expressed concern for upcoming games and chain crews.

November is a very busy month. Conflicts between varsity and youth games will cause problems.

There will be some Saturday consolation varsity games on **November 21** (8 teams = 4 games, regular fees).

Hank Weil (Youth Football Booking Commissioner):

Hank expressed concern also with youth play-offs and varsity games (possible conflicts).

All youth games after today (10/26/2009) we are to wear knickers.

Hank expressed concern about ejections. They are on the increase.

There have been several ejections in the past couple weeks. Stay on top of it. Make sure they deserve it.

Also, games have been running late, officials know this and arrive late. What if they don't run late, Problem! Please show up at your appointed time for the games.

White hats, if your crew doesn't check in within 48 hours, call and have the replaced.

Screw-in cleats are not allowed. Only molded cleats are allowed.

Butt pads are mandatory equipment, if they don't have one, send them out immediately and note there #.

Knees must also be covered and padded.
