### **Dr. Greg Kaiser (WCOA VP of Football):**

The flag clinic scheduled for March 3, 2012 at Plant high school starting at 8:00am was open for discussion. The school is reserved for us. Scrimmages have been planned and officials assigned. Doc once again had prepared the mechanics presentation. New rule changes will be discussed and reviewed.

The FHSAA Football Field Clinic is scheduled for May 19, 2012. More discussion concerning scrimmage locations and clinicians took place to begin to solidify the planning process.

8-man tackle football was discussed. The concept of whether to work split crews with SICOA or not was discussed. The board decided it should be all or nothing. We don't want to work split crews. Ken Calhoun will schedule using available officials.

The current version of the WCOA By-Laws is dated 2007. The board needs to review the By-Laws and keep it up-to-date with regards to association policies. The idea of creating a committee of veteran WCOA members to review the bylaws and update them was discussed.

The web-site is contains outdated material which is in need of removal and updating to the newer and more up-to-date information. There are several documents that need to be updated yearly and kept current.

The WCOA must stay current with FHSAA policies regarding committees and their staffing. There is a minimum requirement of three (3) members per committee. A review of state and association committees is scheduled for this season.

The topic of evaluations was discussed – pros & cons. One major issue is to achieve better consistency among evaluators. Moving forward with evaluations, the number of people on the committee will be decreased to try and eliminate some of the inconsistencies in evaluations. The use of HUDL providing rapid access to game films was well received by members and will be continued.

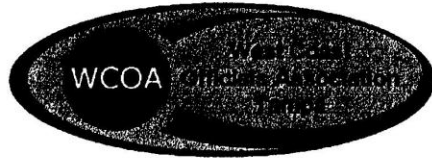
