

## **Minutes of the WCOA Football Board Meeting on 06/18/2012 at Germany Library at 6:00 PM**

Football Board Meeting called to order at 6:00 pm.

### **Dr. Greg Kaiser (WCOA VP of Football):**

The subject of meeting dates for the 2012 season was accepted as final.

Meeting sites for the summer still need to be confirmed as most schools are closed. Lanness Robinson suggested he may be able to provide a site with night school during the summer. If that doesn't work out, we will have to request the help of the private schools.

Tom Johnson started the meeting with some discussion on the upcoming training season.

Training subjects for our membership meeting and the Rookie, Referee & Back Judge clinic were also discussed.

Assignments were suggested for the clinic. The date is tentatively set for August 4, 2012 at St. Joseph Hospital Medical Arts Building & the Northdale field for scrimmages. Once the TBYFL confirms the date of the multi-team scrimmage, we can confirm the clinic date.

Training subjects for the fall meetings must be reported to the state before the season starts.

That has to be addressed, finalized and submitted by the deadline of the first week of July.

The fall varsity schedule is now in the hands of the assignment committee members.

This must be completed and accepted before the season starts in mid-August. Kenny Calhoun has worked on a schedule and we will see what the assignment committee members come up with on their own and compare.

The WCOA has had open opportunity for its members to volunteer to serve on the FHSAA mandated committees.

A roster of those who volunteered has been drawn up and sent to each committee chairman for them to draft their final committee members.

Harold Greenfield has supplied the Board with the current list and members of the WCOA crews.

Several members of crews are not returning for the 2012 season – these positions need to be filed.

It is the duty of each crew chief to compose and direct his own crew (with the Board's approval).

Also furnished was the current Contest Assignment list from 2011 for updating.

A number of promotions have been agreed upon and some officials have switched positions.

Past rookies have been upgraded and known new rookies have been added.

Also assembled was the new Pecking Order for 2012.
